The American Livestock Breeds Conservancy's mission is "Ensuring the future of agriculture through genetic conservation and the promotion of endangered breeds of livestock and poultry." Biodiversity within species, in the form of breeds, is central to agricultural choices and changes. ALBC works with 11 species: cattle, goats, pigs, rabbits, sheep, chickens, ducks, geese and turkeys. ALBC uses three specific strategies to accomplish conservation: discover, secure, and sustain. ALBC uses its network of members and friends and its technical expertise to discover pockets of livestock and poultry that are unique genetic populations. These populations are often highly adapted to their regional habitat. ALBC secures endangered breeds through breed census, pedigree registration, population analysis, DNA analysis, and

ALBC shares its mission through many outreach tools including social media, informational displays and presentations, and press releases. ALBC supports the promotional efforts of its members as additional aids to outreach and long-term conservation.
